

Work test eligibility declaration

- If you're aged between 65-74** ➤ We can accept your employer's mandated contributions (including Super Guarantee contributions), regardless of your age or the number of hours you have worked.
- For all other employer and member contributions, you're required to meet the 'work test' before they can be accepted - to satisfy the work test, you have been gainfully employed for 40 or more hours in 30 consecutive days in the financial year that the contributions are made or the previous financial year (see below).
- If you're over 75 years** ➤ We can only accept your mandated employer contributions.
